Renewal Application Overview

- This application consists of three sections which allow you to earn points towards your Title Professional of Nebraska Designation Renewal.
- You will need a minimum of 300 points to qualify for consideration.
- Renew Title Professional of Nebraska Designation every three (3) years by submitting updated application, application fee and copy of current Nebraska Title Insurance Producer's license and/or Abstracters Certificate.

Requirements

- Complete and score points in all sections of the application – A total of 300 points or more over a three year period are required
- You may not use any points on your renewal that you used to obtain your original certification and/or subsequent renewals.
- Please note that you cannot use any given event in more than 1 category.
- Application will be reviewed and approved by the NLTA Awards and Scholarship Committee
- Have either a Nebraska Title Insurance Producers License and/or a Nebraska Abstracter License (Please include a copy of your current license(s))
- Be a member in good standing of the NLTA or be employed by an underwriter or agent member in good standing
- Adhere to the Code of Ethics of the Nebraska Land Title Association
- Not have had a title insurance producer's license or bar license suspended or revoked by the State of Nebraska or any other State or governmental authority
- Confirmation of your renewal will be sent to you by the NLTA office.
